

# REVISED NOTICE OF RACE

**Date:** Saturday, February 20 and Sunday, February 21, 2010

**Location:** HMBYC, 214 Princeton Ave., Princeton by the Sea. (650) 728-2120  
Racing will be inside the harbor breakwater.

**1) RULES:** This regatta will be governed by the current Racing Rules of Sailing, Rules of each participating class, this Notice of Race and the HMBYC Sailing Instructions.

**2) ELIGIBILITY:** This regatta is open to all.

**3) CLASSES:** Coronado 15, Laser and Cal 20

Six races are scheduled each day, weather permitting; First warning call on Saturday will be 1050 hours. Four entries are required to establish a class. Substitutions allowed on the water between races. Awards given to First, Second and Third place overall in each class.

**4) RACING SCHEDULE:** Skippers' meeting will be held Saturday on the HMBYC patio at 1000 hours. Courses and sailing instructions will be available at registration. Three races are planned before lunch break and three after. Scoring will be low point system with one throw-out if all six races are completed

**5) PROTESTS:** Protests will be heard following each day of racing.

**6) REGISTRATION & FEES:** Entry forms are available at the HMBYC clubhouse and/or web site ([www.hmbyc.org](http://www.hmbyc.org)), and must be filed with the race committee before 1000 hours on race day. The entry fee is \$25.00 for all boats. The **HMBYC Yearly All-Boat, All Race fee of \$125.00** will be accepted if paid on or before race day. Friday and Saturday night dinners will be available at HMBYC for an additional charge. Continental breakfast and lunch will be available for purchase by non-participants for \$5.00 each day.

**7) HOSPITALITY:** The hospitality of HMBYC is extended to all non-member participants for the duration of the regatta. The HMBYC bar will be open during regular operating hours. Participants may bring their boats into the HMBYC storage yard on the Friday before the race with notification and approval of the race chairman.
