

Half Moon Bay Yacht Club Last Gasp Regatta 2020

NOTICE OF RACE

SCHEDULE

The Regatta will be held on Saturday, 7 November 2020. Check-in will be 0900 to 1000. There will be no Sailors' Meeting.

The scheduled time of the Warning Signal for the first race is 1100. Five to seven races are scheduled, time permitting. No races will be started after 1500.

REGATTA RULES

The Organizing Authority for this event is the Half Moon Bay Yacht Club ("HMBYC").

The Regatta will be governed by the rules as defined in the United States Sailing Association's *The Racing Rules of Sailing for 2017 through 2020* (the "RRS").

For C15 competitors, the *Coronado 15 Association Class Rules* also apply, except they are modified to require:

- 1. all racing to be single-handed, and
- 2. all boats to be rigged for mainsail only (no jib).

ELIGIBILITY AND ENTRY

The Regatta is open to boats of the Laser, Coronado 15, and Cal 20



classes. For other classes, please consult the Race Committee.

HMBYC members may enter by registering online (go to the HMBYC website Calendar entry for the date of the regatta). Non-members may enter by sending an email to racing@hmbyc.org with name, boat class, and boat number, or at the Regatta.

Fleets must have at least three (3) boats registered to qualify for a class start. This number may be modified at the discretion of the Race Committee.

FEES

There is no entry fee for this regatta.

SAILING INSTRUCTIONS

The Sailing Instructions (SI's) and this Notice of Race (NOR) will be available on the HMBYC website on the Racing page, and also at check-in.

DISCLAIMER OF LIABILITY

Competitors participate in the Regatta entirely at their own risk; see RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the Regatta.

HMBYC GUESTS

The Club welcomes all non-member participants as guests of the Club for the duration of the Regatta. Participants may bring their boats into the HMBYC storage yard on the Friday before the Regatta with prior notification and approval from the Club.



SAFETY

If you think you've been exposed to COVID-19 or have, within the past 14 days, been in a group without exercising proper social distancing and wearing a mask, then **DO NOT ATTEND** the Regatta.

All participants must wear a mask when not on the water, and maintain social distancing as specified by the San Mateo County Health Department.

All participants must agree to the Half Moon Bay Yacht Club Waiver and Release of Liability. If you have not done so already during a previous regatta, you must provide a signed copy to the Race Committee via email (<u>racing@hmbyc.org</u>) or in person.
